ES-CON JAPAN Ltd. ("ES-CON JAPAN") has resolved at today's Board of Directors meeting to propose, at the Extraordinary General Meeting of Shareholders scheduled for November 29, 2023, an agenda concerning a revision in the amount of remuneration for directors (Auditors Committee Members).

Reason for Revising the Remuneration of Directors (Auditors)

As announced in the press release issued today, Notice of Change in Fiscal Year End, Partial Amendment of the Articles of Association, and Establishment of a Date of Record for the Convocation of Extraordinary General Meeting of Shareholders, ES-CON JAPAN resolved at today's Board of Directors meeting to submit a proposal to this Extraordinary General Meeting of Shareholders to partially amend the Articles of Association. The proposed amendment will include a change in the fiscal year end.
