Notice on Termination of Business Alliance with NISSEI BUILD KOGYO CO., LTD.

ES-CON JAPAN Ltd. (ES-CON JAPAN) announced its decision, made at the Board of Directors' meeting held today, to terminate the basic agreement on a business alliance with NISSEI BUILD KOGYO CO., LTD. ("NISSEI BUILD KOGYO" hereinafter) that had entered into effect on November 2, 2012 ("Alliance Agreement" hereinafter).

1. Reason for termination of the business alliance

ES-CON JAPAN entered into the Alliance Agreement (including capital alliance) with NISSEI BUILD KOGYO on November 2, 2012, for the purpose of achieving synergies among its businesses and building a sustained mid- to long-term relationship between the two companies. Additionally, ES-CON JAPAN implemented an increase of shares through third-party allotment to NISSEI BUILD KOGYO on November 20, 2012.

Due to the secondary offering of the entirety of ES-CON JAPAN's shares held by NISSEI BUILD KOGYO, an agreement was reached to terminate the Alliance Agreement.

2. Specifics of the termination

As of today, NISSEI BUILD KOGYO holds 6,500,000 shares of ES-CON JAPAN. However, the two companies have agreed upon the secondary offering of the entirety of ES-CON JAPAN's shares held by NISSEI BUILD KOGYO. For more information, please refer to the news release titled "Notice on Secondary Offering of Shares" announced today.

Additionally, while the Alliance Agreement will be terminated, ES-CON JAPAN and NISSEI BUILD KOGYO remain on favorable terms and will continue to engage in business.
